Notes to the Accounts for the year ended 31 March 2011

Note

- 1 These accounts have been prepared on a receipts and payments basis as permitted under Charity Commission rules. The accounts have been prepared using a pro-forma provided by the Charity Commission. There is no requirement for an audit or independent examination as the gross income is below £25,000 but the accounts have been reviewed by Mr Nigel Smith who is not a trustee or committee member and have been approved by the Trustees.
- 2 The funds of the Choir are generally unrestricted i.e. all expendable at the discretion of the trustees in furtherance of the objects of the Choir. The only exception is the donation towards the Music Team honoraria which is spent during the year.
- 3 Whilst the total cash balance shown at 31 March 2011 shown is £20,100 it should be noted that some payments and receipts will not appear in the receipts and payments account until the new financial year. These transactions will reduce the available funds to £15,473.

Notes to the Accounts for the year ended 31 March 2011

The adjustment for the Ferneham Hall concert in March 2011 arises because receipts and payments in relation to this concert occurred after the year end. The final net receipt from concerts and events in 2010/2011 after donations to charities is therefore expected to be £880. Some receipts from events were also received directly by organisers e.g the concert the choir took part in at Winchester Cathedral raised £5,000.

- 5 Related Party Transactions and Trustees' remuneration and expenses – There were no related party transactions except as described in this note. An honorarium of £50 was approved for Mark Bourne, Treasurer who is also a Trustee. A total of £207 was paid for expenses incurred by trustees. Expenses paid relate to properly approved costs incurred relating to the work of the charity i.e. stamps, stationery and printer ink.
